- I understand that it is the policy of Myth Merchant Films Inc. not to consider program submissions unless I agree to accept Myth Merchant Films Inc.'s good faith in determining whether the Submission is novel, original, and valuable. If Myth Merchant Films Inc. determines, in its sole discretion, the Submission is novel, original, and valuable, then Myth Merchant Films Inc. agrees to treat my Submission as confidential and not to make any use of it, commercially or otherwise, unless Myth Merchant Films Inc. first negotiates with me for such use.
- 2. I warrant that the Submission is original with me, is solely the result of my own efforts, that I have not copied the Submission in whole or in part from any other work, and that I have the exclusive right to grant all rights and no one else has any right to the Submission.

- (i) that features and elements in my Submission may already be under consideration by Myth Merchant Films Inc. or any of its subsidiary or associated corporations (the "Related Corporations"), because other persons or Related Corporations have independently submitted material containing similar or identical features or elements, and Myth Merchant Films Inc. shall have the unrestricted right to use such material;

- 5. Any controversy relating to Myth Merchant Films Inc.'s alleged use of my Submission shall be resolved by arbitration under the Arbitration Act of Alberta. Any decision resulting from such arbitration shall be final and binding and may be enforced in the courts of Alberta. Any award favorable to me shall be limited to the fixing of compensation based on the compensation normally paid by Myth Merchant Films Inc. at the time of the submission for the use of similar material, to submitters of similar stature.

I have retained a copy of the Submission submitted to Myth Merchant Films Inc., and release Myth Merchant Films Inc. from liability for loss or damage to the Submission. No acts with respect to the Submission (such as Myth Merchant Films Inc. returning it to me) will affect the respective rights of either party under this agreement.
